Therefore, he has filed this Writ Petition with the aforesaid prayer.

2.Today, when the matter is taken up for hearing, the learned Additional Government Pleader appearing for the respondents 1 & 2 would submit that the Revenue Divisional Officer, vide proceedings dated 15.03.2025 directed the petitioner and the fourth respondent to appear on 21.03.2025 for surveying the subject property and thereafter appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.
