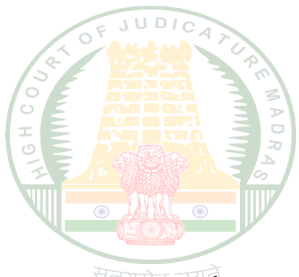

The defacto-complainant represented that they entered into a compromise as they are neighbors and she has no objection to quash the FIR. A compromise memo, dated 13.02.2025 signed by the parties and their respective counsel, is also filed before this Court.

4. This Court has perused the terms of the compromise memo.

5. Considering the nature of the offences and the parties have also entered into a compromise, it is appropriate to allow this petition.

6. Recording the said compromise memo, this petition is allowed and the First Information Report in Crime No.68 of 2025 dated 28.01.2025 on the file of the first
