When the matter was taken up for hearing, the learned counsels on both sides represented that it is case and case in counter and counter case also registered against the 2nd respondent based on the complaint of the petitioner. Now, the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.
