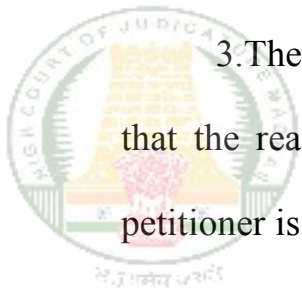
Prayer:
