3. The petitioner seeks for issuance of a Writ of Mandamus to direct the authorities to dispose of his application for assignment of land in his favour. The petitioner relies on the report of the fourth respondent dated 29.11.2019 recommending the assignment in favour of the petitioner.

4. However, the learned Special Government Pleader, on written instructions, submits that the petitioner is not eligible for assignment since he has already owns lands in other survey numbers.
