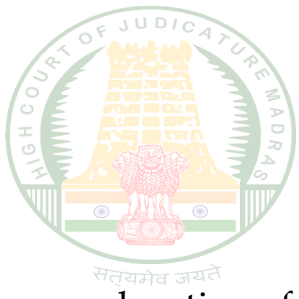
ORDER

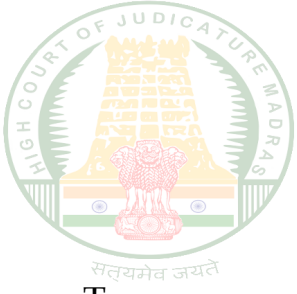
