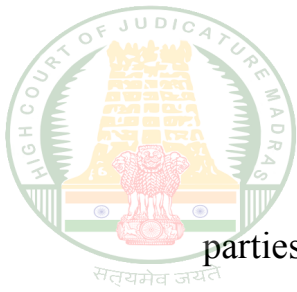

ORDER

This petition has been filed by the petitioner to call for the records pertaining to the First Information Report in Crime No.102 of 2023 dated 27.05.2023 on the file of the first respondent police, for the offences under Sections 147, 294(b), 323 and 506(2) of IPC and quash the same.

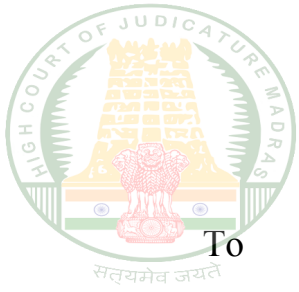
4. This Court has perused the terms of the compromise memo.
