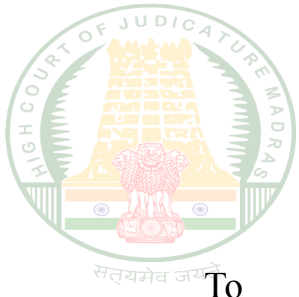
4. The learned counsel appearing for the respondent Nos.1 to 4 has no objection in allowing this Petition.
