ORDER

2. When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) submitted that based on the complaint lodged by the second respondent, an FIR in crime No. 175 of 2023 has been registered, for the offences under Sections 341, 294(b), 323 and 5069i) of IPC. After investigation, final report has been filed before the learned Judicial Magistrate, Manaparai.

3. Since the prayer is to quash the FIR and now, the respondent police has already completed the investigation and filed final report and as per FIR, there are some allegations to constitute the offences, it is for the petitioners to challenge the final report in the manner known to law, if they are aggrieved.
