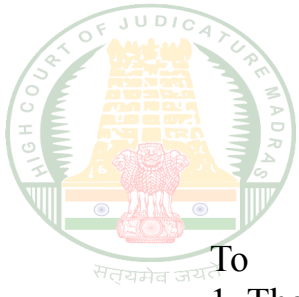
3.The learned Counsel for the petitioner would submit that the encroachments are not removed in entirety.
