3. The marriage registration certificate is produced by daughter of the petitioner. She is present along with her husband Sivasamy.

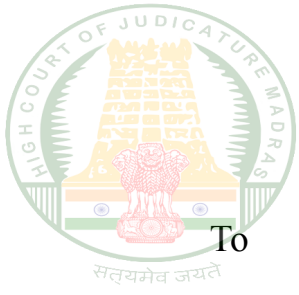
