3. The petitioner's application for patta transfer was erroneously rejected by the second respondent. Challenging the same, the petitioner filed W.P(MD)No.8698 of 2021 which came to be allowed, setting aside

In and by the order dated 17.06.2021, the first respondent was directed to conduct an enquiry and pass orders. Considering the limited scope of the relief sought for, the writ petition is disposed of with a direction to the first respondent to pass orders, on merits, in accordance with law disposing of the petitioner's application dated 05.02.2021 within a period of eight weeks from the date of receipt of a copy of this order.
