ORDER

This civil miscellaneous petition is filed to amend the name of the third appellant as 'Muthuramalingam' instead of 'Nambirajan' and the name of the fourth respondent as 'Thirumalai Nambi' instead of 'Chellappa' in the grounds, affidavit and other petitions filed in the second appeal.

2.Perusal of records shows that right from the trial Court the name of the third appellant is shown only as 'Nambirajan'. According to the counsel for the petitioners that mistake was noticed only recently and the correct name of the third appellant is 'Muthuramalingam'. Hence, this petition. To verify the identity of him, the third appellant was directed to be present before this Court in person along with Aadhar

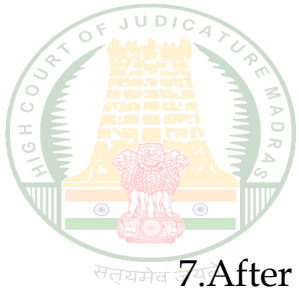
Card and other relevant documents. Any one of the respondents was also directed to

4.Similarly, it is also stated that the name of the fourth respondent is also wrongly mentioned as 'Chellappa' instead of 'Thirumalai Nambi'.

5.In view of the above said mistake committed right from the beginning and since there is no issue with regard to the identity of the parties, this petition is allowed.

6.Registry is directed to carry out necessary amendments in all the matters, wherever it is necessary, including the available trial Court records as well as the first appellate Court records.
