This Court perused the entire materials on record and it is noticed that the order passed by the Controlling Authority under the Payment of Gratuity Act, 1972 vide Na.Ka.No.965/2020/KiVeeTi, dated 08.01.2021, has not been challenged by filing an appeal under Sub-Section (7) of Section 7 of the Payment of Gratuity Act, 1972. However, the respondent No.1 - writ petitioner, while challenging the notice issued by the respondent No.2 herein, under the Revenue Recovery Act, sought for a consequential relief to quash the said order dated 08.01.2021.
