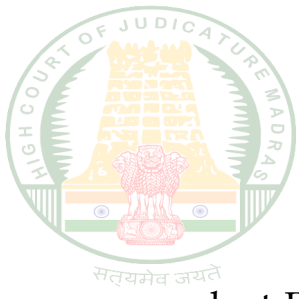

2. Mr.S.S.Manoj, learned Government Advocate (Crl. Side) appearing for the
