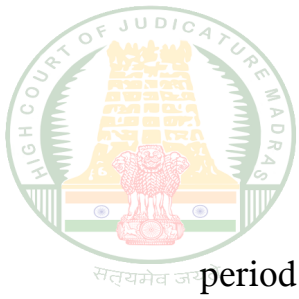

4. Accordingly, the writ petition is disposed of with a direction to the 2nd respondent to consider the representation of the petitioner dated 22.02.2025 in accordance with law and pass appropriate orders within a period of three weeks from the date of receipt of a copy of this order.
