2.It is the grievance of the petitioner that his representation dated 28.02.2025, to remove the encroachments made by the respondents 5 to 16 in the Government poramboke lands bearing Survey Nos.504/4, 508/19, Survey Nos.156/7, 8, 505/20, 506/1, Survey No.503/22, 31, 32, 504/28, 505/26, 27, 506/12, 507/1, 13, 511/1, 511/6, 10 and Survey Nos.503/1, 508/11 and Survey No.157 situated at Sangankulam Village, Palaiyanoor Post, Valarenthal Group, Thiruppuvanam Taluk, Sivagangai District, is kept pending till date without any progress. Therefore, he has filed this Writ Petition with the aforesaid prayer.
