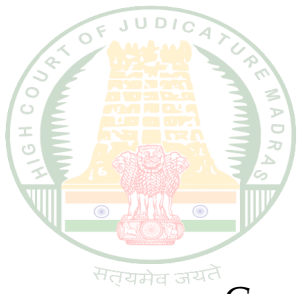

Considering the reasons stated by the petitioners in the affidavit, the time already granted by this court is extended for another period of 15 days from the date of this order.

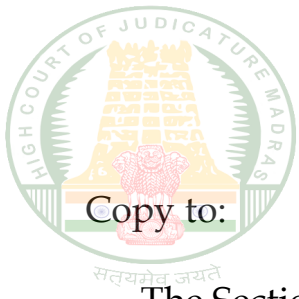
