2.The prayer made in this Writ Petition is to issue a Writ of Mandamus, directing the third respondent herein to grant permission to the petitioner for conducting the “Vadamadu Manjuvirattu” event on 11.05.2025 as part of the Sri Manthaiyamman Temple festival at V.Kalpulichanpatti, Vikkiramangalam Post, Usilampatti Taluk, Madurai District by including the petitioner's village of V.Kalpulichanpatti, Vikkiramangalam Post, Usilampatti Taluk, Madurai District in the Madurai District Gazette based on the petitioner's representation dated 06.03.2025.

2.The petitioner had given a representation to the respondents on 06.03.2025, in this regard. Since the said representation was not considered, the present Writ Petition has been filed.

3.The learned Government Pleader appearing for the respondents 1 to 3, 4 and 6 and the learned Government Advocate (Criminal Side) appearing for the fourth respondent submitted that the representation of the petitioner will be disposed of by the respondents in accordance with law within a time frame.
