4. In view of the said submission, the petitioner has no apprehension at the hands of respondent-Police and hence, this Criminal Petition is dismissed as not maintainable.

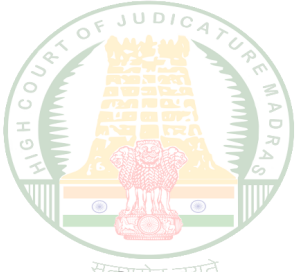
