2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) submitted that based on the complaint lodged by the second respondent, an FIR in crime No. 352 of 2021 has been registered, for the offences under Sections 8(c) and 209b)(ii)(A) of NDPS Act. After investigation, final report has been filed before the learned Judicial Magistrate, Trichy and the same was taken cognizance in S.T.C.No.144 of 2025.
