This criminal original petition has been filed seeking to quash the FIR in Crime No.63 of 2024 on the file of the first respondent .

2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) submitted that based on the complaint lodged by the second respondent, an FIR in crime No. 63 of 2024 has been registered, for the offences under Sections 353 and 506(i) of IPC and Section 4 of TNPHW Act. After investigation, final report has been filed through e-filing on 18.06.2024, before the learned Judicial Magistrate No.II, Srivaikundam.

3.Since the prayer is to quash the FIR and now, the respondent police has already completed the investigation and filed final report and as per FIR, there are some allegations to constitute the offences, it is for
