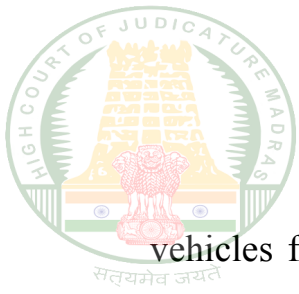

2.By consent, this writ petition is taken up for final disposal at the stage of admission itself.

3.The petitioner has submitted a representation dated 17.02.2025 seeking to forbear the respondents 1 and 2 from permitting the third respondent or any other person to run an industrial establishment in the midst of the residential area of the petitioner's locality. Since the said representation was not considered till date, the present writ petition is filed.
