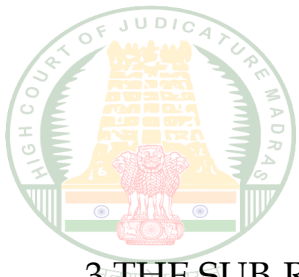

This petition is filed to condone the delay of 60 days in filing the above Writ Appeal.

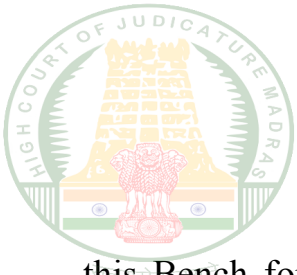
2.Heard the learned counsel for the petitioner, the learned Additional Government Pleader for the respondents 1 to 3 and the learned counsel for the 4th respondent.
