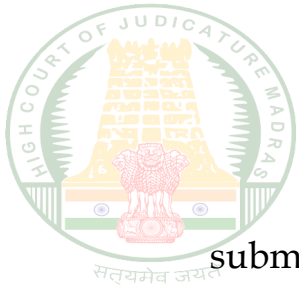

4. Recording the above said submission, the Writ Petition stands disposed of. No costs.

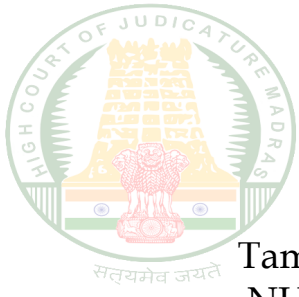
