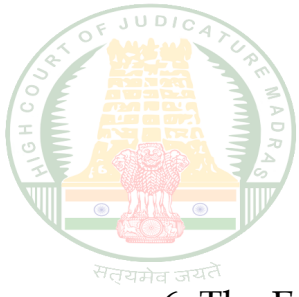

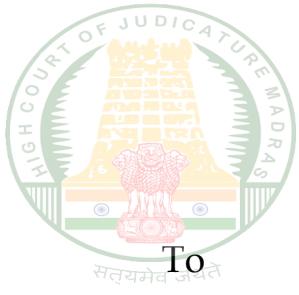
The matter was heard elaborately and orders were reserved on 18.03.2025.
