ORDER : The Court made the following order :-

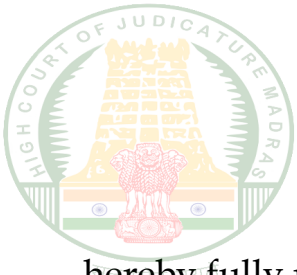
This Petition has been filed to relax the condition imposed in the order passed by this Court in Crl.O.P(MD). No.2248 of 2025, dated 05.02.2025.
