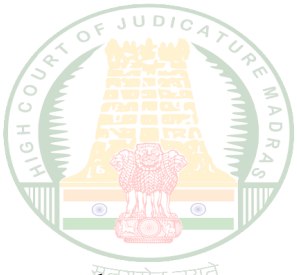
PRAYER :-

2. Mr.S.Gokulraj, learned counsel appearing for the petitioner, submits that

Accordingly, this Criminal Miscellaneous Petition is allowed and the condition No.7(iii) imposed by this Court in Crl.O.P.(MD).No.2931 of 2025 on 21.02.2025 is modified to the effect that the petitioner shall report before the concerned Court, once in a week i.e., on every Monday at 10.30 am until further orders. If the Monday is a holiday, he shall appear on the next working day. The other conditions shall hold good.
