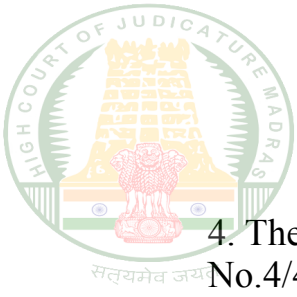

2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent police would submit that they already received the list of the agents and the investigation is still pending in this case and that the respondent police have already included 164 accused persons including the companies and its agents and other individuals.
