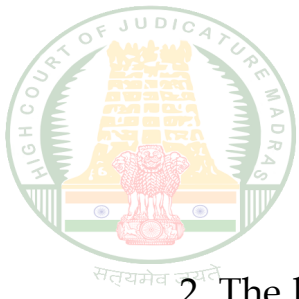

Hence he submits that the petitioner is facing difficulty to stay at Ariyalur and appear before Ariyalur Police Station at 10.00 a.m. and 05.00 p.m.

It is stated that the petitioner has been complying with the condition 4 (iii) imposed in the pre-arrest bail order dated 05.03.2025 passed by the learned Principal Sessions Judge, Theni in Cr.M.P.No.509 of 2025 from 02.04.2025 to 06.04.2025. In view of the substantial compliance, this Court is inclined to modify the condition 4 (iii) of the pre-arrest bail order dated 05.03.2025 passed by the learned Principal Sessions Judge, Theni in Cr.M.P.No.509 of 2025 as 'the petitioner shall appear and report before the respondent-Police weekly once i.e., on every Monday at 10.00 a.m., until further orders'.

4. To the above extent this Criminal Original Petition is ordered. The other conditions shall hold good.
