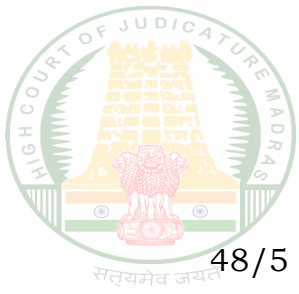
PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct respondents 1 to 4 to remove the encroachment made by respondents 7 to 11, in S.No.48/5 situated at Melilambana Puridam, Choozhal Dasam, Kollankodu Village, Kanyakumari District, for an extent of 1012 sq.ft (187.5 Sq.Ft in Portion No.2 and 825 Sq.feet (length 55 links and breadth 15 links) in portion No.3, totally 1012 Sq.feet) and to restore the Iron Gate and compound wall in original position in Portion No.3 in the expense of respondents 7 to 11 on the basis of the petitioner's representation dated 20.12.2022, within a stipulated time as may be fixed by this Court.
