WEB COPY This Criminal Original Petition has been filed to quash the proceedings pending in C.C.No.20 of 2025 on the file of the learned Judicial Magistrate, Additional Mahila Court, Ramanathapuram District.

2. Based on the complaint given by the defacto complainant, the police has registered FIR in Crime No.15 of 2019 for the offences under Sections 448,294(b),427,386 of IPC and Section 4 of TNPHW Act.

3. When the matter was taken up for hearing, the learned counsel on both sides represented that during pendency of the case in C.C.No.20 of 2025 , the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

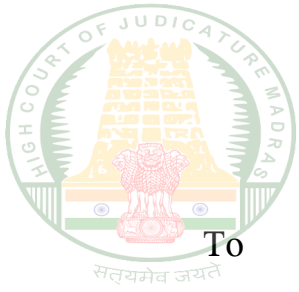
WEB COPY 5. This Court has perused the terms of the compromise memo.
