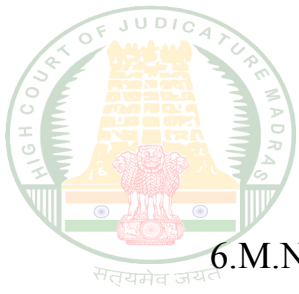

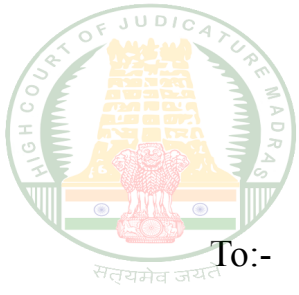

We further grant leave to the review applicant to urge the contentions now putforth before us in the pending civil suits. Both the suits shall be tried jointly.
