ORDER

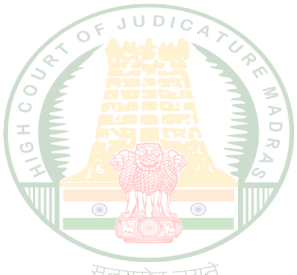
