Survey Numbers 439/1,2, 441, 452/1,2,3, 453/1,2, 454, 455/,1,2, 456, 457/1,2 of Sri Ram Nagar, Mettamalai Panchayat, Sattur Taluk, Virudhunagar District, in accordance with the norms and regulations of the Explosives Act, is kept pending till date without any progress. Therefore, he has filed this Writ Petition with the aforesaid prayer.

3.The learned Government Pleader appearing for the respondents 1 to 6 submits that the representation of the petitioner would be considered and appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.

4.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the third respondent to consider the representation of the petitioner dated 24.07.2024, after giving sufficient opportunity of hearing to the petitioner and the respondents 7 to 10 and pass appropriate orders on merits and in accordance with law within a period of twelve (12) weeks from the date of
