PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying for a Writ of Mandamus, directing the respondents to rectify the mistake crept in the revenue records ie., in Joint Patta No. 1535 and FMB with regard to exact measurement and issue corrected joint patta with an extent of 1 acre 33 cents (0.54 hectares) instead of 0.42.50 hectares (1.04 cents) in respect of property comprised in S.No.256/4 at Samugarengapuram Village, Radhapuram Taluk, Tirunelveli District on the basis of the petitioner's representation dated 04.11.2024 and 03.03.2025.
