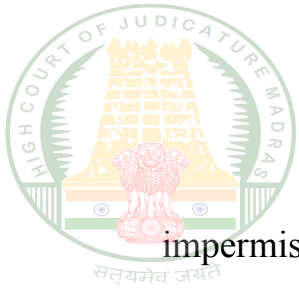

### **ORDER**

Heard the learned counsel for the petitioner and the learned Special Government Pleader for R1 & R2. Issuance of notice to the fifth respondent is dispensed with.

2. The petitioner alleges that in Survey No.69/1 at Vannnaampaaraipatti Village, illegal construction had come up.

3. The learned Special Government Pleader confirms that Survey No. 69/1 has been classified as “Oodai”. Any construction in Oodai is

impermissible. We direct the third respondent to issue notices to the encroachers and have the same removed by adhering to due process of law. The entire exercise shall be completed within a period of 5 months.

4. The Writ Petition is disposed of accordingly. No costs.
