ORDER

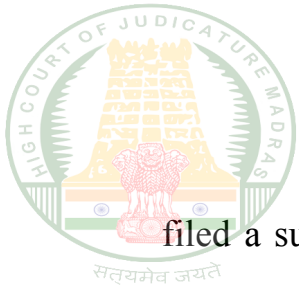
[Order of the Court was made by *J.NISHA BANU, J.*]

2.The petitioner seeks a direction to the respondents 1 to 3 to remove the sand loaded by the 4th respondent in front of the house of the petitioner situated in Survey No.70/2, Sethurapatti Village, Srirangam Taluk, Trichy District before laying cement road in East West road.

3.Mr.P.Thilak Kumar, learned Government Pleader takes notice for the respondents 1 to 3. Notice to the 4th respondent is dispensed with, since no adverse order is going to be passed as against him.

4.On perusal of the affidavit filed by the petitioner, it is seen that the dispute involved in this petition is civil in nature and the petitioner has already

filed a suit in O.S.No.104 of 2024 seeking permanent injunction before the Sub Court, Trichy. Pending the same, he has filed this Writ Petition.
