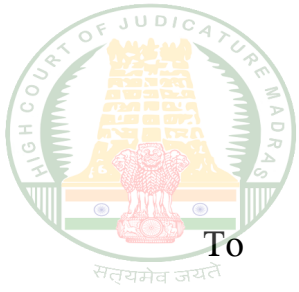
WEB COPY 5. This Court has perused the terms of the compromise memo.
