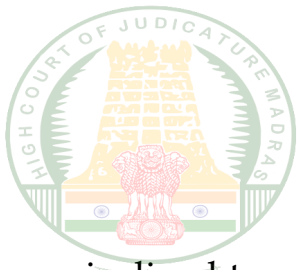

conditions shall hold good.

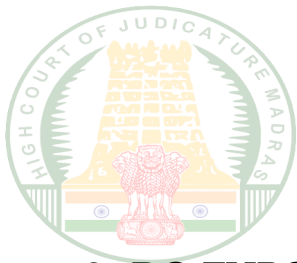
