ORDER

The decree holder in O.S.No.102 of 2012 on the file of the Additional District Court, Palani, Dindigul District, has filed the present Civil Revision Petition for expeditious disposal of E.A.No.57 of 2024.

2. A perusal of the records reveal that the revision petitioner herein has filed the above said suit for the relief of specific performance. The suit was decreed on 24.03.2020. The decree holder has filed E.P.No.12 of 2020 for execution of sale deed. The Court has already executed the sale deed in favour of the revision petitioner.
