ORDER

A perusal of the records reveal that the above said suit has been filed for the relief of declaration that the plaintiff is the legal heir of the deceased Sebasthiyammal and he has also prayed for a mandatory injunction for granting legal heir Certificate in his favour. The plaintiff has further prayed for declaration to declare that the legal heir Certificate issued by the third defendant on 04.06.2021 as null and void. The suit was originally filed before the District Munsif Court, Aranthangi in O.S.No.154 of 2022. The defendants have already filed their written statement. 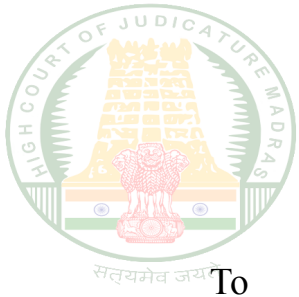
the stage for framing of issues. Hence, the present Civil Revision Petition has been filed seeking expeditious disposal of the above said suit.
