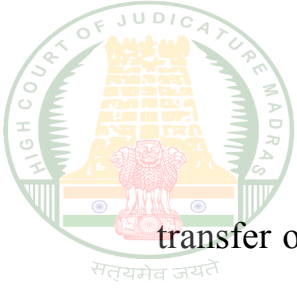

ORDER

Heard the learned counsel for the petitioner, learned Special Government Pleader for the official respondents.

The petitioner, apprehending that his patta no.566 may be recalled by the authorities, in view of the subsequent events, namely the encroachment being made by the respondents 5 to 8 into the petitioner's property, has given his objections to the 1st respondent on 19.07.2024.
