## **ORDER**

The petitioner seeks for survey to be conducted based on his application dated 27.02.2025.

2. With the consent of the learned counsel appearing on either side, the writ petition is taken up for final disposal, even at the stage of admission.

3. I have heard Mr.G.Sridharan, learned counsel appearing for the petitioner and Mr.M.Lingadurai, learned Special Government Pleader appearing for the respondents.

4. The petitioner has been issued patta Nos.2179 and 17 in respect of the subject lands, of which survey is sought for. Though the petitioner has fairly submitted that the suit has been filed in O.S.No.86 of 2020, on the file of the District Munsif-cum-Judicial Magistrate, Thirumayam, where the plaintiffs are none else than his brother's sons and the said suit is pending, there is no interim order granted in the said suit restraining
