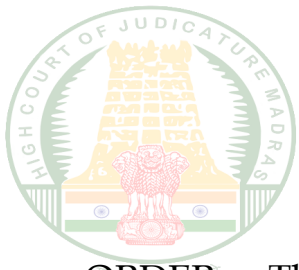

This Criminal Miscellaneous Petition filed under Section 528 BNSS praying to extend the time for deposit 20% of the cheque amount in Crl.R.C.(MD) No.41 of 2025 dated 12.02.2025 on the file of this Court.

Prayer in CRL RC(MD).41 of 2025 :

4. In the result, the Criminal Miscellaneous Petition is ordered.

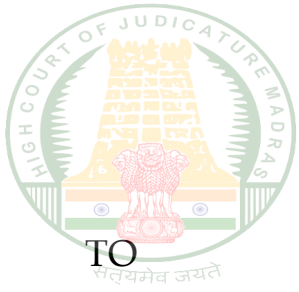
