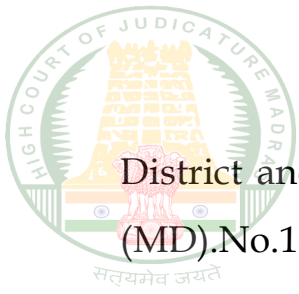

Prayer in CRL OP(MD). 18600/ 2024 :

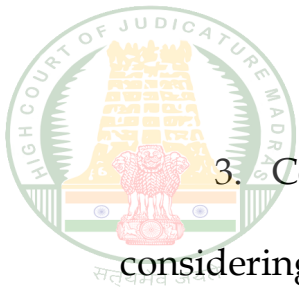
