2.It is the grievance of the petitioner that his representation dated 18.03.2025, to forbear the 6th respondent from conducting Vadamadu Majuvirattu at Arasaneri, Keelamedu, Sivagangai Taluk, Sivagangai District, which is scheduled to be held on 23.03.2025, is kept pending till date without any progress. Therefore, he has filed this Writ Petition.

3.Mr.P.Thilak Kumar, learned Government Pleader, who takes notice on behalf of the respondents 1 to 4, submits that the representation of the petitioner would be considered and appropriate orders would be passed in accordance with law within a period that may be stipulated by this Court.

4.Notice to the 6th respondent is dispensed with, since no adverse order is going to be passed as against him.

5.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the 1st respondent to consider the representation of the petitioner dated 18.03.2025, after giving sufficient opportunity of hearing to the petitioner and the 6th respondent and pass appropriate orders on merits and in accordance with law as quickly as possible. Till such time, there shall be an order of interim stay for conducting Vadamadu Manjuvirattu at Arasaneri, Keelamedu, Sivagangai Taluk, Sivagangai District.
