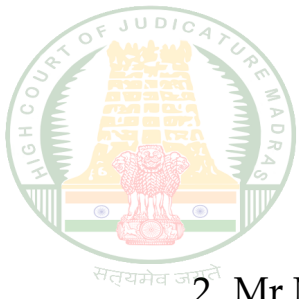
PETITION FOR RELAXATION Under Sec.439(1)b of Cr.P.C

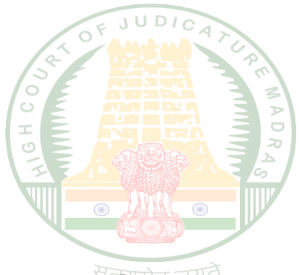
