2. The learned Government Advocate (Crl.Side) for the first respondent would submit that based on the complaint given by the second respondent, they conducted enquiry and filed the Final Report before the learned Judicial Magistrate No.I. Padhmanabapuram. Hence, nothing survives for further adjudication in this petition.

3. Considering the prayer sought for in this petition, this Court, without issuing notice to the second respondent, is inclined to pass orders.

4. The prayer of the petitioners is to quash the FIR in Crime No.383 of 2024 and the first respondent also filed the Final Report before the
