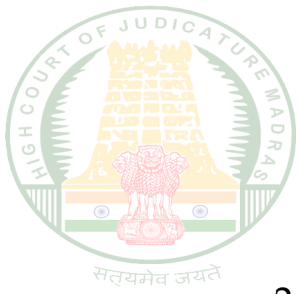
Prayer in WP(MD).No.15376 of 2023:-
